

TERMS & CONDITIONS FOR STALL HOLDERS, READERS & ENTERTAINERS

Along with the good stuff comes the boring stuff, but could you Please READ the Terms and Conditions, they are here for everybody's safety and to help ensure a smooth running of our Festival. 1. Please check in on arrival at check in post at Venue so we can assist you to your pitch and provide you with relevant information for day. (Information will be given nearer the time)
2. Please read our Health & Safety guidelines available NEARER THE TIME and adhere to Health & Safety Regulations at all times.
3. Please DO NOT pitch anywhere else apart from your designated allocated PLOT No.
4. Do not move any barrier fences without permission.
5. You will be able to park your vehicle behind your stall, providing it is no larger than 10ft long. (You can drive up to pitch to unpack etc).
6. When driving onto and into the venue PLEASE note Speed Limit is 5 miles per hour. Only 1 car per stall.
7. You can bring along one friend for free to help, all other helpers will require to have a ticket.
8. Please bring your own coverage & table and chairs.
9. Have a good day and enjoy yourself x
10. Please Adhere to Mystic Faerie Festival Code of Conduct at all times.
11. All stall holders, Therapists and Readers will provide their own up to date & valid Insurance, Public Liability and Proof of Certification.

12. Keep the area around your stall free and tidy from Hazards, ie anything sharp sticking out, anything that can be tripped over, objects hanging at eye level etc and rubbish.
13. All rubbish to be taken home with you.
14. Drugs, Smoking, Weapons or sharp objects perceived to be dangerous are prohibited.
15. Only Alcohol to be CONSUMED is from the Licensed Bar ON SITE.
16. Please be respectful to other stall holders.
17. Please feel free to be a child again.
18. All children must be supervised at all times.
19. All Generators/electrics must be inaccessible to the public.
20. Mystic Faerie Festival Organisers cannot accept responsibly for any loss or damage to your vehicle, stall or contents or children. Please supervise your property at all times. There still can be mischievous Faerie`s out there.....

THERAPISTS

21. All Therapists must work with integrity and within the remit of their qualifications and take on the full responsibility of all client's they work with, during and the aftercare after the festival regarding their clients treatment/treatments.
22. All Therapists must have Equipment that has been Safety checked and is Safe for use.
23. All Therapists must be responsible for any Cosmetic Products they use during a treatment, The Organisers of Mystic Faerie Festival will not be held responsible or liable for Products used or for any allergic reactions or side effects caused from such products.

READERS

24. Readers will not be able to charge more than £40 per hour at any time during the festival.

25. Readers will not be able to predict Deaths or Births or engage in any matters that are under Legal investigation or Legally Bound.
26. Readers will work with integrity and within their own remit.
27. Readers will ask the client to read the Disclaimer before each reading.

CATERERS

28. Caterers must have Equipment that has been Safety checked and is Safe for use.
29. All caterers will provide the relevant & valid Health & Safety documentation and all equipment must be Safety Checked to date.
30. Caterers must ensure that all food and drink is in date & they are hygienic at all times.

ENTERTAINERS

31. All entertainers must have up to date safety checked equipment & must use equipment and electricity/generator safely.
32. All entertainers only work within their own remit and work safely.
